I AM AGREEING TO PURCHASE AN AMERICAN MOLOSSUS PUPPY. I HAVE DONE MY RESEARCH AND AM UNDRSTANDING OF WHAT IT TAKES TO LOVE AND CARE FOR A GIANT BREED LIKE AN AMERICAN MOLOSSUS. I UNDERSTAND THAT THE DEPOSIT IS NONREFUNDABLE. I UNDERSTAND THAT THE PUPPY IS \$6,500.00 EAR AND TAIL CROP IS MANDATORY AND IS \$500. I AM AWARE THAT THE PUPPY WILL BE TRANSPORTED AND AM RESPONSIBLE FOR THE COST WHICH CAN RANGE FROM \$375-\$575 DEPENDING ON MY LOCATION. I UNDERSTAND THAT I AM RESPONSIBLE FOR THIS DOG FOR IT'S LIFETIME AND WILL LOVE AND CARE FOR IT AND WILL BE A RESPONSIBLE OWNER THIS INCLUDES, GOOD FOOD, CARE AND VET BILLS. I UNDERSTAND THAT THIS DOG WILL NOT BE USED FOR DOG FIGHTING. THIS DOG IS SOLD WITHOUT BREEDING RIGHTS. IT CAN ONLY BE BRED WITH OLD WORLD MOLOSSUS DOGS OR WITH WRITTEN OR WITH OLD WORLD MOLOSSUS WRITTEN CONSENT WITH OTHER AMERICAN MOLOSSUS ONLY. SHOULD I BREED THIS DOG WITH ANOTHER BREED OR WITHOUT OLD WORLD MOLOSSUS WRITTEN CONSENT, OLD WORLD MOLOSSU HAS THE RIGHT TO CONFISCATE THE DOG AND I AM RESPONSIBLE FOR A PENALTY OF \$6500.00. I AGREE TO GIVE MY PUPPY BASIC OBEDIENCE TRAINING. I AGREE TO HAVE MY PUPPY CHECKED BY MY STATE LICENCED VET FOR THE HEALTH OF THE PUPPY WITHIN 24 HOURS TO VERIFY THE PUP'S STATE OF HEALTH. SHOULD I FAIL TO DO SO ANY GUARANTEE IS NULL AND VOID. SHOULD I AT ANYTIME NO LONGER BE ABLE TO CARE FOR THE DOG, I WILL NOT SURRENDER THE DOG TO ANYONE EXCEPT OLD WORLD MOLOSSUS. THIS INCLUDES OTHER BREEDERS AND SHELTERS. NO REFUNDS ARE GIVEN. I UNDERTSAND AND AGREE THAT THIS DOG CANNOT BE RESOLD OR REHOMED, SHOULD I NO LONGER BE ABLE TO CARE FOR THE DOG, I AGREE TO GIVE BACK TO THE BREEDER OLD WORLD MOLOSSUS/ MARCUS E CURTIS AT NO CHARGE. I AGREE TO NEVER DISCUSS THE TERMS OF OUR AGREEMENT OR THE HEALTH OF MY PUPPY/ DOG PUBLICALLY.

IF WITHIN 1 YEAR THE PUP SHOULD DIE RESULTING FROM ANY GENETIC DEFECTS, IT WILL BE REPLACED WITH ANOTHER PUP OF THE SAME OR SIMILAR QUALITY AS SOON AS IT'S POSSIBLE IN ORDER OF THE WAITING LIST. NEW OWNER RESPONSABILITIES-SHOW CONFIRMATION BY APPROVED LICENSED VET

ANY LEGAL ACTION WILL BE HELD IN RIVERSIDE COUNTY CALIFORNIA. ALL COURT COSTS AND FEES WILL BE AT THE EXPENSE OF THE PURCHASER. COST OF CONFISCATION DUE TO CONTRACT BREECH WILL BE AT MY COST,
